NATIONAL COUNCIL FOR HOTEL MANAGEMENT JOINT ENTRANCE EXAMINATION (NCHM JEE) - 2021

Registration for the entrance examination for admission to the B.Sc. (Hospitality & Hotel Administration) Course at the Institutes of Hotel Management (IHM) affiliated to the National Council for Hotel Management and Catering Technology (NCHM&CT) for the Academic Year 2021-22, is in progress.

It may be noted that the Information Bulletin for the exam, hosted on the NTA website <https://nchmjee.nta.nic.in> states that the exam will be held in the Computer based mode, i.e. candidates will be required to visit designated exam centres (address of which will be contained in the admit card) on the appointed date and time and appear in the exam, which will be delivered on the computers.

In view of the pandemic situation, taking into consideration the welfare of all concerned and with a view to obviate the need for candidates to travel and visit exam centres on the exam day for appearing in the exam, **it has been decided to conduct the exam, in the online mode (internet based), in supersession of the instruction as regards mode of exam contained in the Information Bulletin.**

In other words, the exam will not be held in the computer based test mode, as indicated in the Information Bulletin hosted on NTA website. Instead it will be held in the online mode (Internet based).

Candidates would not be required to visit any exam centre for appearing in the exam. Instead they will be required to take the exam on their laptops/mobile phones at their location, on the appointed date and time.

The technical and other requirements, process and the special instructions in this regard arising out of the change as aforesaid stated, will be communicated by way of a Public Notice on the NTA website. Candidates will also be communicated individually by way of email.

Invigilation will be carried out online, through AI tools. In addition, the exam will also be proctored online on real time basis through live proctors who will be monitoring the activities of the candidates and take corrective action in case of any unfair means activity by them.

All other terms and conditions and instructions contained in the Information Bulletin remain the same.

Details regarding the submission of online forms are as follows:

Last date for submission of online exam application forms	20 th June 2021 (upto 5.00 PM)
Last date for payment of exam fee online	20 th June 2021 (Upto 11.50 PM)
Correction window	From 21.06.2021 to 30.06.2021.

The revised date of the exam will be announced in due course.
